Membership of all councils and sub-committees is open to all District campuses and centers, and participation from all campuses and centers should be robustly pursued.

Constituent groups may assign alternates who fill in for regular council members when needed. Alternates may vote on behalf of the regular member. Regular members or their alternates who are absent from two or more consecutive council meetings will be considered to hold an “abandoned seat.” Abandoned seats will be referred to constituent groups to fill. If a constituent group fails to fill an abandoned seat in a timely manner, the seat may be filled by any employee or student belonging to that constituency at the College (regardless of established selection/eligibility criteria) for one semester.”

Unless specified in council and sub-committee by-laws, “faculty” indicates full-time or part-time faculty representation.

All councils and sub-committees will reflect the District’s values of diversity, equity and inclusion in practices, procedures and standards;

agreed upon standards based on with appropriate training provided by the District as needed.
