The committee discussed the need for a systematic way to notify students of costs that might be associated with courses. This course currently has travel expenses funded through donors, but if that changed the description would not indicate to the student that they were responsible for the expenses. Course author and dean indicated that costs are covered for the foreseeable future and if there were no funds to cover travel the course would likely not be offered. There was discussion about whether to include a possibility that is unlikely (e.g. student expenses in excess of \$200) when it might impact enrollment and might be an unneeded warning.

There was also discussion about whether the actual estimated cost number needs to be in the description. While not necessary in the description, making that information available for Financial Aid office would be helpful for students in particular programs.
