Assessment of Compliance with Title IX, Clery Act and VAWA Willard Lewallen Dr. Lewallen reported that the college is working with MPC and Cabrillo College to hire a consultant to assess each districts' policies/practices to help identify gaps and make recommendations to ensure compliance with Title IX, Clery Art, and VAWA.
- 8. High School Graduate Enrollments Outcomes Data Willard Lewallen The CPC received information on high school graduate enrollments from feeder high schools since 2013 to current. The data show enrollments are good and steady for all high schools, except North Monterey County High School (NMCHS). Dr. Lewallen has requested information from neighboring community colleges (MPC, Gavilan, Cabrillo) to learn if and how many local high school graduates are attending neighboring community colleges. In addition, Dr. Lori Kildal is looking into course offerings at NMCHS and is meeting with NMCHS administration about this possibility. Also, the CPC received fall 2015 information on the number of high school graduates transferring directly from high school to CSUs/UCs.
